About Schneider

- Schneider results .Schneider announces a good 3rd quarter with organic revenue growth of +8% and +6.8% cumulatively over the first 3 quarters. Schneider maintains its targets for revenue (between +6 and +8%) and EBITA margin (between 60 and 80bpm
- PEG contribution: management makes a first proposal to increase to €1,700. Negotiations are still ongoing.
- **Medical examination**: too many employees do not show up even though it is a legal obligation. Failure to attend without a valid reason is punishable by disciplinary action.
- Drug and alcohol screening: Management will launch random campaigns and targeted tests, as it is
 responsible for employee safety. Refusing the test is equivalent to a positive test and may lead to
 disciplinary action.
- Schneider/StarCharge JV: Following the CFTC's requests, employees will be able to choose whether or not to join the new JV. Employees will be received individually to express their choice. Employees who wish to stay with Schneider will be repositioned within the group.
- Election of employee representatives for the management of Schneider Equity Funds (FCPE): Vote electronically between November 5 and 26 for the 9 candidates of the CFTC, CFDT and CFE-CGC union who are committed to honestly representing your interests.
- Schneider was condemned €207 million for collusion on prices of low-voltage equipment with Legrand, Rexel and Sonepar between 2012 and 2018. Schneider contests the conclusion of the Competition Authority
- **Teleworking:** At Schneider, no questioning of the agreement is in sight, as long as employees respect the rules of the game.
- **Rental car**: from 1/11/2024, if you drive in specific areas, ask for a category J or R (equipped with snow tires)
- Breaking news: Olivier BLUM becomes CEO of Schneider Electric, replacing Peter HERWECK effective November 4th, 2024.
